1. Use of personal information for the purpose of holding the race;

Acquired personal information may be used for race management, including but not limited to the determination of eligibility, editing and production of the official program, announcement of results, publishing official website, for the purpose of usage by media's coverage of the race, and for the provided sevices by supporting organizations.

2. Use of personal information for the purpose of novel coronavirus disease (COVID-19) infection control measures;

All participants shall submit a health check sheet. Personal information provided on this check sheet shall be treated as strictly confidential, and shall only be used to check health condition of each participants, to judge whether they are fit to participate in the race or not. Personal information shall not be provided to third parties without the consent of the individual concerned with the exception of cases permitted by law, such as the Act on the Protection of Personal Information. However, in the event that infected individuals or individuals suspected of infection are discovered at the race venue, personal information shall be provided to public health centers.

- 2) The race will be broadcasted on television and/or on the Internet.
- 3) The use of images of the race by third parties without the permission of the Organizers is prohibited, including the distribution of images and videos on the Internet.
- 4) Images of the race including but not limited to photos, articles, personal records may be used by the Organizers and third parties approved by the Organizers for PR purposes in the program, posters and other PR materials for the race, and in such media as TV, radio, newspapers, magazines and the Internet.

### **Doping Control**

- # Doping control will be conducted in accordance with anti-doping rules of World Athletics and Japan Anti-Doping Agency.

  Urine or blood samples (or both) will be taken in doping tests carried out before or after the race.
- # All athletes need to bring photo ID in case you are appointed to the doping test.
- # TUE: If a competitor needs to use a prohibited substance or prohibited method stipulated in the prohibited list of the International Standard for Therapeutic Use Exemptions for medical reasons, that competitor must submit a TUE application. ### COVID-19

- # The Organizers shall administer the race by taking every possible step to prevent the spread of infection, ensuring that all infection control measures are implemented based on the JAAF's "Guidance on the resumption of road racing.
- # Athlete who refuses to comply with the COVID-19 infection control measures set out by the Organizers shall not be allowed to participate
- # The content of these guidelines may be added to or changed depending on the updated status of infection or at the request of the Japanese government, municipal authorities, etc.

#### Others

- # This race will be held as Grade 1 (G1) race of Japan Marathon Grand Championships series.
- # Athletes must ensure to undergo a health check by a medical doctor beforehand. The organizers will provide first-aid treatment in the event of an accident occurring during the race, etc., but will accept no liability for any other forms of medical treatment.

# The person other than the officially approved participant himself is not permitted to participate in the race. All participants must present valid photo ID by himself at Athlete Bibs pick-up.

# All clothings and items which participants will wear at the race should follow the WA advertising regulations and will be checked at the first call.

# Participants are not allowed to take any photos or videos at start/finish area or on the course. Videos or photographs of the race taken by participants/third parties without the permission of the Organizer must not be used for commercial purposes, including on social networking services (this applies irrespective of whether the party concerned is a company, organization, competitor, or other individual).

# Participants who are forced to withdraw from the race after his application was accepted shall submit notification of withdrawal to the race office.

# Application fee are non-refundable, even when the race is cancelled or suspended due to any reason ( earthquakes, storms, floods, snowfall, contingent events, accidents, epidemics, infectious diseases, and situations similar to these )

# In regard to the displaying of flags and banners on the course roadside and inside the stadium, only the competitor's name is permitted, so long as these are not affixed to buildings but held by hand. The displaying of company names etc. to which competitors belong is not allowed by the organizer.

# The race shall adhere to all related laws and regulations in Japan

# The race is held in accordance with competition rules prescribed separately by the Organizer.

# Participants shall not be permitted to participate in the race in case they fail to comply with the race regulations, etc., or do not follow the instructions of the Organizer. Participants who is found to have been in violation of any of the above after having crossed the finishing line shall have their record erased.

# If any damage to race administration occured by anyone's acts in violation of Japanese laws, the race regulations, etc., or his/her failure to follow the instructions of the organizer, the organizer reserves the right to take legal action against the individual concerned, such as a claim for damages.
